The newly elected members of AAA Council are:

**Steven C. Bennett** is a partner at Scarola Zubatov Schaffzin PLLC, with a practice that focuses on domestic and international commercial litigation and arbitration, including cases involving bankruptcy, construction, corporate, securities and other disputes. He has served on the Commercial Panel of the AAA as an arbitrator for more than a decade, and on the AAA Large Case Advisory Committee for more than 15 years. He taught arbitration law at Brooklyn Law School for 9 years. He is the author of *Arbitration: Essential Concepts* (Am. Law Media Publishers, 2002) and co-wrote the New York Law Journal column on Arbitration for five years. Recent publications include: “The Deal-Making Process: A Litigator’s Perspective,” *Practical Lawyer* 1-5 (2019); “‘Hard’ Tools For Controlling Discovery Burdens in Arbitration,” *Mealey’s Litigation Report* 1-22 (2018); and “Use of Experts in Arbitration: Alternatives for Improved Efficiency,” *Mealey’s Int’l Arbitration Report* 1-11 (2018). He is currently Co-Chair of the ADR Ethics Committee of the New York State Bar Association, and past Co-Chair of the ADR in the Courts Committee of the New York State Bar Association.

**Dr. Kabir Duggal** is an attorney in Arnold & Porter Kaye Scholer 's International Arbitration and Public International Law Practice Groups in New York. He also acts as a Consultant for the United Nations Office of the High Representative for Least Developed Countries, Landlocked Developing Countries and Small Island Developing States (UN-OHRLLS) on the creation of a novel "Investment Support Program" (which was shortlisted by Global Arbitration Review for the category of “Best Developments” for 2018). He has also conducted training and capacity-building



sessions for several Governments including Colombia, Saudi Arabia, Myanmar, India, among others on public international law and dispute resolution matters. Dr. Duggal is a Lecturer-in-Law at the Columbia Law School, teaching "International Investment Law and Arbitration." And Managing Editor for Columbia Law School's "The American Review of International Arbitration".
